What is dual enrollment?

Georgia's dual enrollment program provides HS students the opportunity to take college level coursework for credit which can be applied towards both high school and college graduation requirements.



How it works...



Apply

- Student applies to the dual enrollment program at the college they are interested in attending as a dual enrollment HS student

College Admissions

- Student accepted or denied by the college if they meet the college's dual enrollment admission requirements

Registration

- Student chooses classes from list of approved dual enrollment college course(s)
- Student will have both a college schedule and a high school schedule

Take the Class(es)

- Student completes the course during the fall, spring and/or summer semester
- Final grades assigned by the college professor

Transcripts

- Student then has a HS transcript *and* a college transcript
- Dual enrollment grades and credits on college transcript are added to the HS transcript

Graduate HS

- College credits applied toward HS graduation requirements

Continue Education

- Apply to College
- Student applies/transfers earned college credits to college they attend after HS*

***Students are responsible for verifying with college which dual enrollment credits will be accepted and/or transferrable to that institution.**



Dual Enrollment Eligibility

Who can participate in dual enrollment?

- Students enrolled in a GA public or private high school
- Students in grades 10th, 11th and 12th grade (10th graders must have a 1200 SAT or 26 ACT to take academic courses)
- Students who meet the dual enrollment admissions requirements at selected post-secondary institution
- Must not have already received a high school diploma
- No residency or citizenship requirement



How much does it cost students to participate in dual enrollment?



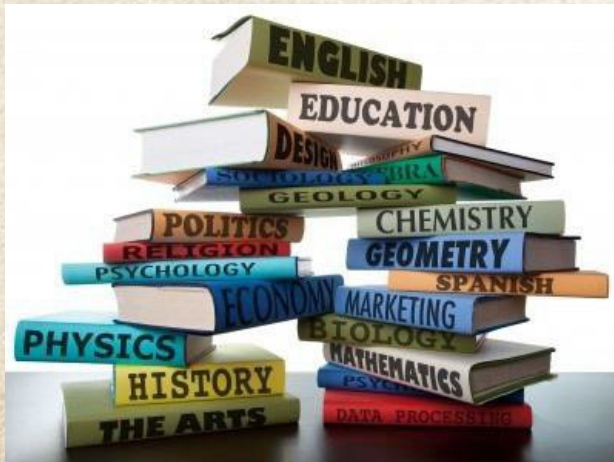
The GA Student Finance Commission covers the cost of tuition, mandatory fees and textbooks for approved classes (students must meet all dual enrollment eligibility requirements)

The postsecondary institution cannot charge the student any additional tuition or mandatory fee costs for approved dual enrollment courses

Credit Hours paid for by dual enrollment are not counted toward the Attempted Hours or Combined Attempted Hours limit for HOPE and Zell Miller Scholarship at the postsecondary level

What college classes are approved for dual enrollment?

**Each college has different course offerings approved for dual enrollment.*



Students can take courses in areas including:

Core subjects: English, math, science, social studies, & foreign language

Online courses

**Courses available to each student will vary depending on grade level and college course pre-requisites.*

Elective courses are no longer covered

Option B - Another Dual Enrollment Option

Students are awarded a high school diploma and college credential(s) after meeting all of the following:

1. Successful completion of the following state-required high school courses or their equivalent:
 - ◆ 2 English (American Literature required)
 - ◆ 2 Math (Algebra 1 required)
 - ◆ 2 Science (Biology required)
 - ◆ 2 Social Studies
 - ◆ Health and PE
2. Completion of all required EOC exams
3. Completion of an Associate Degree, Technical Diploma or two Technical Certificates of Credit (TCC) in one specific career pathway that lead to industry certification or license.

Dual Enrollment Types

Part Time vs Full Time

Part Time

- ▶ Less than 12 college credit hours
- ▶ Blend of DE classes on the college campus and HS classes at PCHS
- ▶ Schedule must have a total of 5 courses
- ▶ Need to coordinate DE courses with course offerings at PCHS

Full Time

- ▶ Total of 12-15 college credit hours
- ▶ All classes are taken on the college campus
- ▶ No courses would be taken at PCHS
- ▶ Student is still enrolled at PCHS and can participate in sports, extra curricular activities, clubs and events.
- ▶ Student will graduate from PCHS

What type of student is a good fit for dual enrollment?

- ▶ Can articulate why he/she is interested in dual enrollment
- ▶ Meets college dual enrollment admissions requirements
- ▶ Can follow through on multi-step tasks
- ▶ Self-motivated
- ▶ Self-starter
- ▶ Mature
- ▶ Organized
- ▶ Takes initiative
- ▶ Responsible
- ▶ Has a specific pathway planned for graduation
- ▶ Can overcome any logistical challenges to traveling to and from the local high school and college



**Transportation to and from GMC and GRCCA is currently provided for the 2022-2023 school year*

Benefits of Dual Enrollment

- ▶ Students are able to begin accruing college credit and high school credit at no expense (transportation, mandatory fees, and books are waived)
- ▶ Increase access for all students by removing financial barriers
- ▶ **Students can retain full HOPE hours while earning college credit**
- ▶ Expanded course offerings
- ▶ GA residency has been waived (out-of-state transfer student can participate)
- ▶ If graduation requirements are met early during 12th grade year, they can continue participation the rest of that year
- ▶ **All DE core courses receive .5 per semester extra weight for HOPE and Zell Miller Scholarship purposes (up to 4.0) and all DE courses receive 1.0 extra weight for high school GPA**

NEW POLICY!!!!!!!

- 30 hour semester and 45 hour quarter cap for DE funding
- Students will not be allowed to retake a course
- 9th graders are not allowed to dual enroll
- 10th graders can take CTAE courses, but must score 1200 on the SAT or 26 on the ACT before the semester starts to take academic courses

Dual Enrollment Application Process

1. Take the PSAT, SAT/ACT or ACCUPLACER and receive a qualifying test score.
2. Complete college application process including:
 1. Be sure to use your correct social security number when you apply.
 2. Be sure to apply as a **Dual Enrollment** student and not "Freshman."
 3. Send official test scores from the testing organization.
 4. Request your high school transcript to be sent to the college through your gafutures account.
 5. Send AP Scores, if applicable. (can be done in May during AP Testing)
 6. Send immunization form and verification of lawful presence (drivers license and/or birth certificate)
3. Once accepted, schedule a meeting with your counselor.
 1. Student provides proof of acceptance letter from college.
 2. Complete participation agreement and advisement form.
 3. Counselors sends agreement and advisement form to college dual enrollment advisor.

What are the expectations of students in dual enrollment?

Remember you are a high school student and a college student!

Dual Enrollment Students are expected to....

Complete the application process themselves

Meet deadlines for PCHS and the college

Maintain communication with PCHS clubs, athletics, senior class activities, events, etc.

Communicate directly with the college with questions about DE application, registration, classes, grades, etc.

Check college email account regularly

**communication between the college and the DE student is primarily done via email*





Dual Enrollment Deadline

PCHS students wanting to start participating in dual enrollment in the Summer or Fall 2023 must be admitted and clear to register by **May 1, 2023** (no exceptions)!
